

Run for the Son Instructions

Thank you for being part of Run for the Son. Please read the material in this packet. We have worked to make it detailed enough to answer your questions, yet simple enough to understand.

The most important thing is to get started. So set a goal and start seeking sponsors. You can find sponsors among friends, family, co-workers, businesses, and churches. Many times you miss a sponsor simply because you did not ask.

The Run for the Son Sponsor Form and Receipt are printed on the brochure. Please see the completed illustration below. If you are present when the sponsor gives you a check, fill out both forms, including the amount donated. Then tear off the bottom portion, **SPONSOR FORM**, to keep for your records (you may need this information if you choose to send thank you notes after the Run). Give the remaining part of the brochure, which includes the **RECEIPT**, to the sponsor for their tax-deductible gift.

If you are corresponding by mail, then fill out the bottom portion, or the **SPONSOR FORM**, as well as the top form, or **RECEIPT**, and mail the entire brochure, personal letter, and recommended self-addressed stamped envelope. The sponsor will have to fill out their information, indicate the amount of money donated, and should return the **SPONSOR FORM** to you with their donation. Keep the money collected in your packet envelope or you may send it to the Support Center throughout the year. Indicate the monies are for RFS and enclose a note with your name, member number, chapter name and number. Write RFS, your member number, and your chapter number in the memo field on each check.

On the first Saturday in May, take your packet to your chapter Run. Be sure all the donations (made out to CMA) are in your packet. Complete the outside of the packet and give it to the RFS Secretary. If you are not riding with a group, do not forget to call

the Hotline at (870)389-6196 with your total amount collected. Send in your packet and all money collected by May 20 to: CMA, PO Box 9, Hatfield, AR 71945. Make all checks payable to CMA. Donations are tax-deductible. **PLEASE DO NOT SEND CASH.**

Remember, the packets must be postmarked by May 20 in order to be counted towards this year's national goal, to be eligible for national awards, or to receive RFS incentives. Any monies postmarked after May 20 will go towards the following year's goal.

Top Fund-Raiser Awards

Each year, we honor the top ten individual fundraisers and top ten chapters with special recognition at the CMA National Rally. The individuals will each receive a Limited Edition, matted, and framed print from CMA. The top ten chapters will receive a custom banner.

 Twelve mission trips will be given by Missionary Ventures, two trips per region. A trip will be given to the top individual fundraiser in each region. The remaining trips will be awarded to the top individual fundraiser in the leadership position of State Coordinator or Area Representative.

 Individuals winning trips are responsible for travel to the port city.

 If any of the top individual fundraisers described above do not wish to take a mission trip, the trip will automatically be awarded to the next qualifying person.

 CMA paid staff and families are not eligible for trips.

INCENTIVES

Goodie/ToolBox Certificates will be awarded as incentives. Everyone raising \$100 or more will receive a RFS T-shirt. Those raising \$500 or more will receive a Goodie/ToolBox Certificate for the appropriate level reached as well as a T-shirt. The different certificate levels will not be combined. You will be able to use the certificate to purchase CMA Goodies or ToolBox items at the regular price. No discounts will apply. Items with a CMA logo larger than 3 1/2" are available only to those members who have completed the Ministry Team course or were members prior to March 1, 1997. The top ten individual fundraisers will receive a Limited Edition, matted, and framed print from CMA.
